The cyclic rate shall be 7 cycles per minute unless the rate is controlled by the door operating mechanisms. No loss of serviceability and damage of the hinges and its accessories shall be observed after the test.</p>	<p>PASS</p>

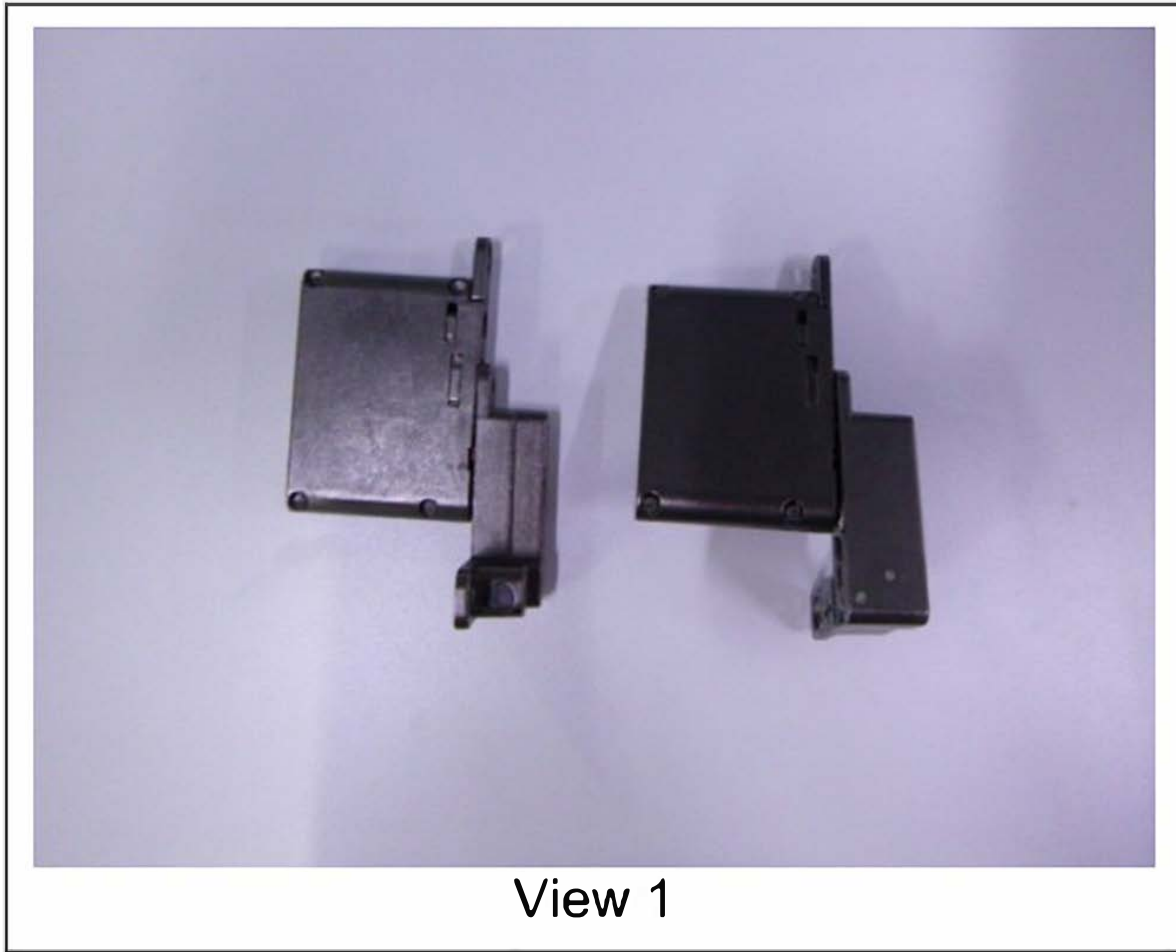
